## Case Study: Haulage - 1.27 million miles over 12 months

We have proven savings of more than 8% from third parties in the haulage industry. The Besblock fleet, including 27 brand new Euro VI trucks, have been using SulNOxEco™ Diesel Conditioner in their fuel for 12 months providing "real world" data to support our laboratory test results.

### Fuel Savings

- 741,258 miles @ 8.1 mpg from April 2020 to March 2021 vs. 535,720 miles @ 7.51 mpg from April 2019 to March 2020 → **8% saving**
- AdBlue costs reduced due to reduction in NOx production from improved combustion

### Particulate Matter Filters

- PM filters not changed for 12 months and no issues with PM sensors for 12 months (£350 each) yielding further cost savings
- No limp mode recorded for 12 months, previously a regular monthly occurrence with expensive maintenance and downtime costs

### Emissions Reductions

# Immediate progression towards carbon neutrality

## Cars & Vans

Car & van drivers can expect to see some of the best improvements in fuel economy when using SulNOx. Just consider the different driving styles spread across a range of petrol, diesel and hybrid vehicles over a variety of driving conditions, ranging from a daily commute, to motorway cruising. Manufactured by Nouryon BV, SulNOxEco™ Fuel Conditioner is verified by Bureau Veritas to be compatible with all diesel and gasoline type fuels including EN590, EN16709 Biofuels (B20, B30), EN228 gasoline (E5 and E10) and is certified to comply with, and not alter, the specification of any of these fuel types. SulNOxEco™ Fuel Conditioner is the only fuel additive that will not void your engine warranty as it remains fully compliant to recommended engine manufacturer standards.



# Case Study: Bus and Coach Operator - E&M Horsburgh

Over 16,000 kms of regular travel routes primarily from Livingston to Edinburgh hospitals using SulNOxEco™ Diesel Conditioner. Real world variations such as driving conditions, traffic, different drivers etc. evidenced a 9% fuel saving/increase in economy, from 12.98mpg to 14.16mpg. This is very significant both economically and environmentally, and corresponds well with evaluations of other vehicle types.
